What do I need to know?

The Forum of Nuclear Regulatory Bodies in Africa (FNRBA) was established in 2009 and became formally recognized as a regional intergovernmental organization in September 2019.

The objective of the Forum is to enhance, strengthen and harmonize radiation protection, nuclear safety and security regulatory infrastructure, safety, and security culture among its Member States.

Why is FNRBA important?

The IAEA supports professional knowledge networking through its Global Nuclear Safety and Security Network (GNSSN). With over 20 national and regional networks, GNSSN assists IAEA Member States to connect, collaborate and communicate on nuclear and radiological safety and security issues.

Through GNSSN and the Technical Cooperation Programme, the IAEA actively supports FNRBA to assist its African Member States in strengthening and sustaining their national capacity building in safety and security.

The Forum is supported by a collaborative portal that serves as an effective platform for the exchange of regulatory experiences, good practices, and lessons learned among relevant nuclear regulatory bodies.

Collaborating with FNRBA

FNRBA operates under six thematic areas:

- 1. Legislative and Regulatory Infrastructure
- 2. Radiation and Waste Safety
- 3. Nuclear Safety Infrastructure
- 4. Emergency Preparedness and Response
- 5. Transport Safety Infrastructure
- 6. Nuclear Security Infrastructure

The FNRBA portal on the GNSSN platform is designed to facilitate information exchange on regulatory infrastructure in the Member States and serves a knowledge management system for the six thematic areas.

What does FNRBA offer to its members?

- Adopt and adapt common approaches and methods for enhancing nuclear and radiation safety;
- A collaborative platform to facilitate the exchange of information and regulatory experiences;





- Provide strategic guidance and planning for addressing regulatory challenges and oversight for nuclear and radiation facilities and activities;
- Facilitate access to capacity building activities (e.g. workshops and training, eLearning etc.) according to FNRBA thematic areas; and
- A forum to strengthen the partnership and capacity building in the region and beyond.
