- a/ Payment plan agreement was concluded with the Agency in 2009. Cambodia has made the necessary payments in 2016 as required by the payment plan; however, since the Government of Cambodia was in default of its payment plan and lost its voting rights, it should now formally request the restoration of voting rights.
- b/ Payment plan agreement concluded with the Agency in September 2007 and started in 2008. However, the Dominican Republic has not made the necessary payments since 2008, as required by the plan. The minimum amounts required as per the payment plan agreement are €1 549 847 plus US \$35 064.
- c/ Payment plan agreement was concluded with the Agency in 2009. Gabon has not made the necessary payments in 2016 as required by the plan. The minimum amounts required as per the payment plan are €219 296 plus US \$16 265.
