Ведомости денежных взносов в МАГАТЭ

Доклад исполняющего обязанности Генерального директора

1. Информация о денежных взносах в Агентство, отражающая положение на конец 2018 года, приводится в Финансовых ведомостях Агентства за 2018 год², а информация о денежных взносах в текущем году — в записках Секретариата 2019/Note 39 и 2019/Note 70. Для удобства Генеральной конференции ведомости взносов обновлены, чтобы отразить положение по состоянию на 13 сентября 2019 года, и приводятся в приложении в следующем виде:

Добавление 1 (РБ). Взносы в регулярный бюджет Добавление 2 (ФОС). Авансы в Фонд оборотных средств

Добавление 3 (ФТС). Добровольные взносы в Фонд технического сотрудничества

Добавление 4 (НРП). Оплата начисленных расходов по программе Добавление 5 (РНУ). Оплата расходов по национальному участию

2. Статья XIX.А Устава гласит:

«Член Агентства, за которым числится задолженность по уплате Агентству денежных взносов, лишается права голоса в Агентстве, если сумма его задолженности равняется сумме взносов, причитающихся с него за два предыдущих года, или превышает эту сумму. Генеральная конференция может, однако, разрешить такому члену Агентства участвовать в голосовании, если она находит, что неуплата вызвана не зависящими от него обстоятельствами».

Для сведения Генеральной конференции в добавлении 6 (ПГ) (Государства-члены, не имеющие права голоса) перечислены члены, к которым относятся положения статьи XIX.А Устава, по состоянию на 13 сентября 2019 года. В таблице по каждому из этих членов указана, в частности, минимальная сумма, подлежащая выплате, чтобы избежать применения этой статьи.
