Estado de las contribuciones financieras al OIEA

Informe del Director General

1. En los *Estados Financieros del Organismo correspondientes a 2019*² se informa sobre el estado de las contribuciones financieras al Organismo al final de 2019, y en las Notas de la Secretaría 2020/Note 27 y 2020/Note 45 se informa sobre el estado de las contribuciones financieras en el año en curso. A fin de facilitar los trabajos de la Conferencia General, los estados de las contribuciones se han actualizado para dar cuenta de la situación a 18 de septiembre de 2020 y se reproducen en el anexo como sigue:

2. El artículo XIX.A del Estatuto dispone lo siguiente:

“El miembro que esté en mora en el pago de sus cuotas financieras al Organismo no tendrá voto en el Organismo cuando la suma adeudada sea igual o superior al total de las cuotas adeudadas por los dos años anteriores. La Conferencia General podrá, sin embargo, permitir que dicho miembro vote si llegare a la conclusión de que la mora se debe a circunstancias ajenas a la voluntad de dicho miembro.”

Para información de la Conferencia General, en el apéndice 6 (VR Attachment 6) —Estados Miembros sin derecho de voto— se indican los Estados Miembros a los que era aplicable el artículo XIX.A del Estatuto el 18 de septiembre de 2020. Para cada uno de esos Estados Miembros, el cuadro muestra, entre otras cosas, el pago mínimo requerido para evitar la aplicación de este artículo.
