Report by the Director General

1. Following the adoption of the Convention on Early Notification of a Nuclear Accident and the Convention on Assistance in the Case of a Nuclear Accident or Radiological Emergency at the first special session of the General Conference, both Conventions were opened for signature on 26 September 1986. The representatives of 50 States signed the two Conventions in Vienna on that date, and the list of signatories is set out in the Appendix.
2. The Conventions will be also opened for signature at the Headquarters of the United Nations in New York from 6 October 1986.
3. Norway expressed its consent to be bound by the two Conventions upon signature. Denmark and Czechoslovakia expressed their consent to be bound by the Convention on Early Notification upon signature; this Convention will therefore enter into force on 27 October 1986.
