SCALE OF MEMBERS' CONTRIBUTIONS FOR 1961

Report of the Programme, Technical and Budget Committee

1. At its thirty-second meeting on 29 September 1960 the Committee took up item 13 of the agenda - Scale of Members' contributions for 1961. It had before it two documents on this subject. The first was a memorandum by the Director General (GC(IV)/124) explaining why he considered it necessary to delay the submission of a suggested scale until an appropriate time during the session. In the second (GC(IV)/COM.1/49) the Director General submitted, within the framework of a draft resolution, a suggested scale based on the Agency's membership as at 26 September 1960.
2. The Committee, by 38 votes in favor, none against and with no abstentions, approved the action proposed by the Director General in document GC(IV)/COM.1/49, and accordingly recommends for adoption by the General Conference the following draft resolution.

Decides further that any State that becomes a Member of the Agency during the remainder of 1960 or in 1961 shall be assessed as appropriate for contributions to the Agency's regular budget for those years, and for its advance to the Working Capital Fund, by applying to its United Nations percentage the same coefficient as was applied in the case of Member States whose rates of assessment are included in the scales of assessment for 1960 and 1961.
