APPLICATIONS FOR MEMBERSHIP OF THE AGENCY

Applications by Kenya and Madagascar

Recommendations by the Board of Governors

1. On 27 July and 4 September respectively the following letters received by the Director General, the first from the Acting Prime Minister of Kenya and the second from the Minister for Foreign Affairs of Madagascar, were communicated to the Board:

Letter from Kenya

"EXT.171/233/34

"9 July 1964

"R. No. 9436

"In the name of the Government of Kenya, I have the honour to submit an application for membership of the International Atomic Energy Agency.

"I wish to assure you, in the name of my Government, that Kenya is willing to carry out the obligations of membership of the Agency and to act in accordance with the purposes and principles of the Charter of the United Nations.

"A formal instrument of acceptance of the Statute establishing the Agency will be deposited by my Government after Kenya's admission has been approved by the General Conference on the recommendation of the Board of Governors in accordance with Article IV.B of the aforementioned Statute."

Letter from Madagascar

"No.1151 - AE/OI/AIEA/1

"25 August 1964

"I have the honour to apply to the International Atomic Energy Agency for admission of the Malagasy Republic to membership in 1965.

"On behalf of the Government of the Malagasy Republic I should like to assure the Agency that the Republic is willing to carry out the obligations that fall to Members of the Agency in accordance with its Statute and the purposes and principles of the United Nations Charter."

2. On 11 September the Board considered these two applications for membership of the Agency in the light of Article IV.B of the Statute, and determined that Kenya and Madagascar were willing and able to act in accordance with the purposes and principles of the Charter of the United Nations. The Board accordingly recommends that the General Conference approve the two States for membership of the Agency, and submits the two draft resolutions below for the consideration of the Conference.

Draft resolution A

APPLICATION BY KENYA FOR MEMBERSHIP OF THE AGENCY

The General Conference

(a) Having received the recommendation of the Board of Governors that Kenya should be approved for membership of the Agency,^{*/} and

(b) Having considered Kenya's application for membership in the light of Article IV.B of the Statute,

Approves Kenya for membership of the Agency.

Draft resolution B

APPLICATION BY MADAGASCAR FOR MEMBERSHIP OF THE AGENCY

The General Conference

(a) Having received the recommendation of the Board of Governors that Madagascar should be approved for membership of the Agency,^{*/} and

(b) Having considered Madagascar's application for membership in the light of Article IV.B of the Statute,

Approves Madagascar for membership of the Agency.
