Decides further that any State that becomes a Member of the Agency during the remainder of 1969 or in 1970 shall be assessed for its advance to the Working Capital Fund, and for contributions to the Agency's Regular Budgets for these years, by applying to its United Nations percentage assessment as appropriate the coefficient used to calculate the scales for the assessment of Members' contributions for 1969 and 1970<sup>1/</sup> respectively.
