Resolution adopted during the 158th plenary meeting on 3 October 1972

SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1973

The General Conference,

Applying the principles it has established for the assessment of Members' contributions towards the Agency's administrative expenses^{1/},

1. Decides that the individual base rates and the resulting scale of assessment of States' contributions to the Agency's Regular Budget for 1973 shall be as set forth in the Annex hereto; and
2. Further decides that in the event of the State in respect of which no assessment is provided for in the Annex participating in the Agency's activities, or of a State becoming a Member of the Agency, during the remainder of 1972 or in 1973, it shall be assessed in respect of one or both years, as appropriate:
 - (a) For an advance to the Working Capital Fund, in accordance with Financial Regulation 7.03^{2/}; and
 - (b) For a contribution towards the Agency's administrative expenses, in accordance with the principles the Conference has established for the assessment of Members for such contributions^{1/}.
