MEMBERS' CONTRIBUTIONS TO THE AGENCY'S REGULAR BUDGET FOR 1980

The computation of the individual base rates and the resulting scale of assessment

1. The first step in computing the individual base rates and the resulting scale of assessment of Members' contributions to the Agency's Regular Budget for the year 1980 is to divide the total amount to be assessed into a "non-safeguards" component and a "safeguards" component [1]. The total assessment proposed is \$ 74 920 000 [2], of which the non-safeguards and safeguards components are \$ 53 422 000 and \$ 21 498 000 respectively. The latter component consists of the appropriation specifically proposed for safeguards (\$ 19 396 000); plus \$ 2 457 000 representing a pro rata share of the proposed appropriation for the adjustment of programme cost estimates [3]; less \$ 265 000 representing a pro rata share of the cash surplus for 1978 and the excess income for 1979, used to finance the appropriation, which share was determined in accordance with the method of computing the scale of assessment for the year to which each relates and \$ 90 000 representing the income it is estimated will be received from non-member States during the year 1980.

2. The next step is to derive a base rate of assessment for each Member of the Agency [4] based on the scale used by the United Nations to assess contributions from its Members to its budget for the years 1978-79 [5]. This is done in Table 1 below, the coefficient 1.068201 used in column (4) being the same as that used in the preceding year. Accordingly, with no change in the membership of the Agency, the base rates of assessment for all 110 Member States are the same for 1980 as they were for 1979.

It will be seen from the end of the foregoing table that the United Nations percentage assessments for Members of the Agency that were also Members of the United Nations amount to 94.03 per cent, and that the United Nations rate of assessment for the other Members of the Agency amount to 1.20 per cent. To the figure of 95.23 per cent, obtained by combining these two percentages, a coefficient is applied to establish the base rates of assessment for all Member States of the Agency as will give a total of 100.00 per cent. In accordance with the principles established by the General Conference [6], however, the coefficient is not applied in the case of the Member bearing the United Nations highest assessment, nor of the 29 Members each bearing the United Nations lowest assessment. This coefficient is therefore calculated as follows:

4. It is now necessary to determine the respective shares of the safeguards expenses to be borne by Members on the list drawn up by the Director General for the purpose of identifying the Members who receive partial relief in respect of their assessment for the safeguards component of the Regular Budget in accordance with the principles established by the Conference in 1977 [7]. It will be noted that the list is the same as in 1979. The dollar amount of safeguards expenses borne by each Member State on the list is the same as the corresponding amount assessed in 1977. The results are set forth in Table 2 below [8].

5. It will be noted from the foregoing table that a total of 77 Members will be required to contribute \$ 511 823 (2.38079%) of the total safeguards component of \$ 21 498 000 [9]. The remaining \$ 20 986 177 (97.61921%) will need to be borne by 33 Members, the share of each Member being calculated as shown in Table 3 [10].

The coefficient is obtained by dividing the percentage of the safeguards component remaining to be financed (97.61921%) by the total of the base rate of assessment of the 33 Members listed in the table above (87.33%).

6. The individual share of each Member in the safeguards component of the total assessment having thus been determined, the next step is to calculate each Member's share of the non-safeguards component. This is done by applying each Member's base rate of assessment to the non-safeguards component (\$ 53 422 000) [11]. The results are set forth in Table 4 below, which shows in column (6) the total assessment of each Member State. Column (7) shows the resulting scale of assessment for 1980, the percentage assessments being expressed to five places of decimals in order to reflect each Member's share of the Regular Budget to the required accuracy.
