## REPORT ON VOLUNTARY CONTRIBUTIONS PLEDGED TO THE TECHNICAL ASSISTANCE AND CO-OPERATION FUND FOR 1995

1. The purpose of the following table is to inform delegates to the thirty-eighth regular session of the General Conference about the pledges of voluntary contributions to the Technical Assistance and Co-operation Fund for 1995 made by Members of the Agency up to 5 p.m. on 16 September 1994.
2. It is foreseen that the Conference will consider the matter of voluntary contributions to the Technical Assistance and Co-operation Fund in a plenary meeting at which the President will report on the contributions pledged by that time. Revisions of the present document will be issued as the session proceeds for the purpose of keeping the Conference informed of the growth in the total value of the pledges that Members have made.
3. Delegates who have not yet done so are invited to communicate their Government's pledges as soon as possible to the officer who will be sitting during the plenary meetings at a table marked "Voluntary Contributions" in the Plenary Hall, and who at other times will be in office A-443 on the second floor.
