SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1996

1. The Director General submits herewith to the General Conference a draft resolution whereby the Conference may set, in accordance with Article XIV.D of the Statute, the scale of assessment of Members' contributions to the Agency's Regular Budget for 1996. The scale annexed to the attached draft resolution has been prepared in accordance with the principles established by the General Conference¹ and on the assumption that the Conference will approve the revised arrangements for the assessment of Members' contributions towards the Agency's Regular Budget which are the subject of document GC(39)/23/Add.2. The scale, based on the Agency's membership as of 31 July 1995, includes one new State, Yemen, which became a Member on 14 October 1994.

2. With regard to the scale annexed to the attached draft resolution, on the basis of the revised principles set forth in document GC(39)/23/Add.2 the Director General has drawn up a list of Members meeting the criteria laid down there for partial relief in respect of their assessments of the safeguards component of the Regular Budget. The list comprises 91 Members (see Table 2 in the Appendix). The remaining 31 Members will contribute on a proportionally increased basis in order to make up the balance of the safeguards expenses (see Table 3 in the Appendix).

3. It will be noted that the following draft resolution also provides for approval by the General Conference of the base rate of assessment of each Member. This has been derived from the scale used by the United Nations to assess contributions from its Members to its Regular Budget for 1995 and adopted by the General Assembly in resolution 49/19 B on 29 November 1994. The 1995 scale of the United Nations is adjusted by applying a mathematical coefficient to compensate for differences in membership between the Agency and the United Nations.

4. The calculations that were made in order to establish both the individual base rates and the resulting scale of assessment are reproduced for the information of the Conference in the Appendix.

5. Member States are urged to inform the Director General by 1 January 1996 as to when their Regular Budget contributions will be paid to the Agency. This information is required to enable the Secretariat to prepare cash forecasts on the basis of which the programme will be implemented.

Draft resolution

SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1996

The General Conference,

Applying the principles it has established for the assessment of Members' contributions towards the Agency's Regular Budget [^],

1. Decides that the individual base rates and the resulting scale of assessment of Members' contributions to the Agency's Regular Budget for 1996 shall be as set forth in the Annex hereto; and
2. Determines, pursuant to Financial Regulation 5.09 [**], that in the event of a State becoming a Member of the Agency during the remainder of 1995 or in 1996 it shall be assessed as appropriate:
 - (a) For an advance or advances to the Working Capital Fund, in accordance with Financial Regulation 7.04 [**]; and
 - (b) For a contribution or contributions towards the Agency's Regular Budget, in accordance with the principles the Conference has established for that purpose.

A P P E N D I X

MEMBERS' CONTRIBUTIONS TO THE AGENCY'S REGULAR BUDGET FOR 1996

The computation of the individual Regular Budget assessments

1. As a first step in computing the individual Regular Budget assessments, the Agency's Regular Budget for 1996 is divided into a "non-safeguards" component and a "safeguards" component^[1]. The total assessment proposed is US\$ 36 977 000 plus the equivalent in United States dollars of AS 2 199 335 000, which, at an exchange rate of AS 12.70 to US\$ 1.00, amounts to US\$ 210 153 000^[2]. Of this total the "non-safeguards" component amounts to US\$ 24 437 000 plus the equivalent in United States dollars of AS 1 409 954 000 (US\$ 135 457 000 at an exchange rate of AS 12.70 to US\$ 1.00) and the "safeguards" component to US\$ 12 540 000 plus the equivalent in United States dollars of AS 789 381 000 (US\$ 74 696 000 at an exchange rate of AS 12.70 to US\$ 1.00). (The latter component consists of the appropriation specifically proposed for safeguards less US\$ 500 000 of estimated income to be received from non-member States during 1996^[3] and less US\$ 126 000 of estimated expenditures connected with assistance to Member States in the field of physical protection^[4].)
2. The next step is to derive a base rate of assessment for each Member of the Agency on the basis of the scale used by the United Nations to assess contributions from its Members to its budget for the year 1995^[5]. This is done in Table 1.

3. It will be seen from the end of the foregoing table that the United Nations percentage assessments for Members of the Agency that were also Members of the United Nations amount to 98.66 per cent and that the United Nations rates of assessment for the other Members of the Agency amount to 1.22 per cent. The total figure of 99.88 per cent obtained by adding these two percentages is multiplied by a coefficient to establish the base rates of assessment for all Member States of the Agency, which will give a total of 100.00 per cent. In accordance with the principles established by the General Conference ^[6], however, the coefficient is not applied in the case of the Member bearing the highest United Nations assessment or of the 45 Members each bearing the lowest United Nations assessment. The coefficient is therefore calculated as follows:

4. It is now necessary to determine the respective shares of the safeguards component to be borne by the Members qualifying to receive partial relief in respect of their assessment for the safeguards component of the Regular Budget in accordance with the revised arrangements as set forth in document GC(39)/23/Add.2. The following list shows the 91 Member States (hereinafter referred to as "shielded" Members) qualifying to receive partial relief and the contributions to the safeguards component to be borne by each of them. It will be noted that in columns (2) and (3) of Table 2 the safeguards assessment amounts for each Member have been calculated on the basis of half of its base rate. In accordance with the transitional arrangements as set forth in document GC(39)/23/Add.2, these amounts are compared with the contribution for 1995 ^[7]. One-fifth of the difference is added to the contribution for 1995 in order to obtain each Member's final share of the safeguards assessment for 1996, which is shown in columns (4) and (5).
