SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1997

1. The Director General submits herewith to the General Conference a draft resolution whereby the Conference may set, in accordance with Article XIV.D of the Statute, the scale of assessment of Members' contributions to the Agency's Regular Budget for 1997. The scale annexed to the attached draft resolution has been prepared in accordance with the principles established by the General Conference^[1]. The scale, which is based on the Agency's membership as of 31 July 1996, includes two new States, Bosnia and Herzegovina and the Republic of Georgia, which became Members on 19 September 1995 and 23 February 1996 respectively.

2. With regard to the scale annexed to the attached draft resolution, 92 Members (hereinafter referred to as "shielded" Members) will receive partial relief in respect of their assessments for the safeguards component of the Regular Budget (see Table 4 in the Appendix). The remaining 32 Members (hereinafter referred to as "unshielded" Members) will contribute on a proportionally increased basis in order to make up the balance of the safeguards expenses (see Table 5 in the Appendix).

3. It will be noted that the following draft resolution also provides for approval by the General Conference of the base rate of assessment of each Member. This has been derived from the scale used by the United Nations to assess contributions from its Members to its Regular Budget for 1996 and adopted by the General Assembly in resolution 49/19 B on 29 November 1994. The 1996 scale of the United Nations is adjusted by applying a mathematical coefficient to compensate for differences in membership between the Agency and the United Nations.

4. The calculations that were made in order to establish both the individual base rates and the resulting scale of assessment are reproduced for the information of the Conference in the Appendix.

5. Member States are urged to inform the Director General by 1 January 1997 as to when their Regular Budget contributions will be paid to the Agency. This information is required in order to enable the Secretariat to prepare cash forecasts on the basis of which the Agency's programme will be implemented.

Draft resolution

SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1997

The General Conference,

Applying the principles it has established for the assessment of Members' contributions towards the Agency's Regular Budget [*],

1. Decides that the individual base rates and the resulting scale of assessment of Members' contributions to the Agency's Regular Budget for 1997 shall be as set forth in the Annex hereto; and
2. Determines, pursuant to Financial Regulation 5.09 [**], that in the event of a State becoming a Member of the Agency during the remainder of 1996 or in 1997 it shall be assessed as appropriate:
 - (a) for an advance or advances to the Working Capital Fund, in accordance with Financial Regulation 7.04 [**]; and
 - (b) for a contribution or contributions towards the Agency's Regular Budget, in accordance with the principles the Conference has established for that purpose.

A P P E N D I X

MEMBERS' CONTRIBUTIONS TO THE AGENCY'S REGULAR BUDGET FOR 1997

The computation of the individual Regular Budget assessments

1. As a first step in computing the individual Regular Budget assessments, the Agency's Regular Budget for 1997 is divided into a safeguards component and a non-safeguards component ^[1]. The total assessment proposed is US\$ 34 601 000 plus the equivalent in United States dollars of AS 2 254 352 000, which, at an exchange rate of AS 12.70 to US\$ 1.00, amounts to US\$ 212 109 000 ^[2]. Of this total the safeguards component accounts for US\$ 11 995 000 plus the equivalent in United States dollars of AS 841 578 000 (US\$ 78 261 000 at an exchange rate of AS 12.70 to US\$ 1.00). The basis for the calculation of the safeguards component is shown in Table 1. As can be seen from the table, this component comprises all of programme L (Safeguards) and part of programme M (Security of Material) - namely, sub-programme M.1 (Information) and sub-programme M.2 (Protection of Nuclear Material); in addition, it includes sub-programme element O.1.07 (DDG Safeguards). As in the past, an amount of US\$ 500 000 of income estimated to be recoverable under safeguards agreements with non-member States during 1997 ^[3] was subtracted from the total. The non-safeguards component refers to all other programmes and amounts to US\$ 22 606 000 plus the equivalent in United States dollars of AS 1 412 774 000 (US\$ 133 848 000 at an exchange rate of AS 12.70 to US\$ 1.00).

2. The next step is to derive a base rate of assessment for each Member of the Agency on the basis of the scale used by the United Nations to assess contributions from its Members to its budget for the year 1996 [4]. As will be seen from Table 2, the United Nations percentage assessments for Members of the Agency that were also Members of the United Nations amount to 98.9475 per cent and that the United Nations rates of assessment for the other Members of the Agency amount to 1.2200 per cent. The total figure of 100.1675 per cent obtained by adding these two percentages is multiplied by a coefficient to establish the base rates of assessment for all Member States of the Agency, which will give a total of exactly 100 per cent. In accordance with the principles established by the General Conference [5], however, the coefficient is not applied in the case of the Member bearing the highest United Nations assessment or of the 45 Members bearing the lowest United Nations assessment. The coefficient is therefore calculated as follows:

3. It is now necessary to determine the respective shares of the safeguards component to be borne by the "shielded" Members. In accordance with the Revised Arrangements for the Assessment of Members' Contributions towards the Agency's Regular Budget [GC/RES/(39)11, sub-paragraph 1(c)(i)], "shielded" Members are not obliged to contribute to any increase in the safeguards budget beyond zero real growth. Accordingly, the amount of US\$ 2 909 000 which reflects a programme increase in the safeguards budget beyond zero real growth was deducted from the safeguards component for the purpose of calculating the shares of the "shielded" Members. Table 3 shows the distribution of the safeguards assessment between "shielded" Members and "unshielded" Members.

4. Table 4 lists the 92 "shielded" Member States and the contributions to the safeguards component to be borne by each of them. It will be noted that in columns (2) and (3) of Table 4 the safeguards assessment amounts for each "shielded" Member were calculated on the basis of half of its base rate. In accordance with the transitional arrangements contained in sub-paragraph 1(d)(i) of General Conference resolution GC/(39)/RES/11, these amounts were compared with the contribution for 1995 ^[6]. Two-fifths of the difference were added to the contribution for 1995 in order to obtain each "shielded" Member's final share of the safeguards assessment for 1997, which is shown in columns (4) and (5).
