Introduction

The following pages contain financial and statistical data supplementing the Technical Co-operation Report for 2002. Again this year, the information is grouped under three headings as listed below, which allows the reader to make a comprehensive review of all information related to one subject. However, in a continuing effort to provide concise and transparent information, changes have been made in some of the tables from the presentation in 2001.

The countries are grouped by region in most of the tables. Annex 1 provides an alphabetical listing by region of all countries that are mentioned in this report.

Unless otherwise specified, all amounts are expressed in United States dollars. As most figures are rounded to thousands of US dollars, the amounts in tables may not add up exactly to the totals shown due to rounding.

A. Resources and Contributions

The financial tables and graphs in this section show the resources received from various sources for technical co-operation activities.

B. Disbursements

The financial tables and graphs in this section show actual disbursements (monetary outlays and in-kind support provided) for the year 2002 and, in some tables, for previous years as well.

C. Non-financial Indicators

The tables and graphs in this section provide figures on the actual physical outputs delivered through the technical co-operation programme, rather than the cost of the outputs. In some cases, figures on financial outputs are provided to complement that information.

The information contained in this Supplement is available in electronic format upon request. It is also available on GovAtom (restricted access). The Secretariat welcomes comments and suggestions for future improvements.

A. Resources and Contributions

Table A.1 Available resources: 1993–2002

This table shows resources by source of funding, based on the year in which the funds became available. The ‘other income’ of the Technical Co-operation Fund (TCF) includes assessed programme costs (APCs) received, interest income, and gains/losses on exchange. Other resources (extrabudgetary funds from Member States, United Nations Development Programme (UNDP), and in-kind) are shown separately.

Table A.2 Technical Co-operation Fund: 1993–2002

The ten-year development of the target for contributions to the TCF, the amounts pledged, and the payments against these pledges are shown. The payments as a percentage of the target gives the rate of attainment. In this table, contributions are shown not by the year in which they became available but by the programme year for which they were pledged and paid. Therefore, new pledges or withdrawals against prior year targets, as well as payments, are recorded against that year, and the percentages for earlier years may change.

Table A.3 Member States’ contributions pledged and paid to the Technical Co-operation Fund: 2002

This table shows a grand total of \$73 022 630 for the TCF target; however, all other tables in this report refer to the target of \$73 000 000 approved by the General Conference. The difference represents the shares of three new Member States, because they were not included in the original scale of assessment for 2002. The table is sorted according to the percentage of the target pledged. Of the 134 Member States, 63 pledged their full target (or more), 20 made partial pledges, and 51 made no pledge in 2002.

Table A.4 Assessed programme costs: 1997–2001

The Member States are arranged according to the percentage of total APCs paid in respect of the total billed for the past five years. The latest year shown is 2001 because the APC bill is only communicated to the Member States in the second quarter of the following year. This table accounts for an outstanding amount of \$3 599 077. For a complete listing of all outstanding amounts going back to 1982 and totaling \$7 111 782, see *The Agency’s Accounts for 2002* (document GOV/2003/25), Schedule S9.

Table A.5 Status of extrabudgetary funds: 2002


This table shows the status of extrabudgetary funds from each donor. Included in this table under Part B are funds from countries for their own projects, designated ‘government cost-sharing’. A total of 52 countries and three organizations are represented. Also included is the Nuclear Security Fund. Amounts shown here refer only to funds made available to the Department of Technical Co-operation in accordance with Board directives to make use of the competencies of the Department in implementing the Nuclear Security Action Plan. The ‘Funds available 1 January 2002’ column of the table represents the total of the unliquidated obligations and the unobligated balance carried forward from the end of 2001.

Table A.6 In-kind support: 2002

This table shows the in-kind support provided by 72 Member States and six international organizations. For in-kind support, the resources and delivery are equal.


AVAILABLE RESOURCES: 1993–2002

B. Disbursements

Table B.1 Disbursement summary: 2002

This table shows, by sub-component and by funding source, the total technical assistance furnished to 105 countries and one territory as well as to regional and interregional projects. Fellowship disbursements from regional and interregional projects have been distributed to the individual recipient countries. Miscellaneous disbursements against project budgets amounting to \$49 100 are included in the equipment column. The amount under 'Global' represents final disbursements of \$19 600 made against the special \$1 million approved by the Board to support additional staff in the Department of Technical Co-operation in 2001. General miscellaneous costs, amounting to \$675 800, are shown separately.

Table B.2 Disbursement summary with apportionment of regional/interregional projects: 2002

This table shows, by recipient country, assistance provided both from country programme activities (see Table B.1) and from activities carried out under regional and interregional programmes. Amounts shown under the column heading 'Assistance reported under Regional/Interregional category in Table B.1' have been apportioned on the basis of countries participating in the specific project or activity. These amounts do not represent audited transactions at the recipient country level.

Table B.3 Disbursements by Agency programme and region: 2002

The table gives details on the disbursements made for 18 Agency programmes involving technical co-operation. The graphs, one for each region, give in percent the disbursements by Agency programme. Programme T in the technical co-operation project context is used primarily for human resource development and capacity building. The amount also includes \$675 800 for miscellaneous costs and \$19 600 for the additional support staff approved by the Board.

Table B.4 Disbursements by sub-component: 1998–2002

This table provides a breakdown of disbursements by sub-component and funding source for the past five years. The costs of equipment procured for training courses are included under 'Training courses' to present a complete picture of the costs of training courses. 'Miscellaneous' refers to disbursements relating to all components for telex charges, health insurance, copying fees, and for other minor items or services. In 2002, it also included a charge for radiation protection services totaling \$81 700.

Table B.5 Disbursement summary: 1958–2002

This table provides a summary of all assistance provided by sub-component and by funding source since the beginning of the Agency's technical co-operation activities in 1958. The sub-components utilized are those that can be compared over the full time span. For example, in early years disbursements for fellows and scientific visitors were combined. Since original data no longer exists to allow a proper split into two separate categories, 'Fellowships' includes amounts for both fellows and scientific visitors. Likewise, disbursements for meetings are included under 'Experts', and amounts for government cost-sharing and donor states are included under Member States.

Table C.2 International experts and lecturers by place of origin: 2002

This table shows the number of individuals who undertook expert or lecturer assignments during 2002. From the total of 3351 assignments, 37% were carried out by persons from developing countries, 38% by persons from developed countries, and 25% by Agency staff. It should be noted that Agency staff, as well as staff of other international organizations, are listed under their nationalities.

Table C.3 Technical co-operation trainees: 2002

The left half of the list shows the number of people from a given country who received training in 2002, either through a fellowship/scientific visit or through a training course. People from a total of 107 recipient countries were trained.

The right half of the list shows the number of trainees (fellows/scientific visitors and training course participants) hosted by a given country. A total of 112 countries served as hosts of technical co-operation training programmes in 2002. Information on the number of regional/interregional training courses hosted by Member States has been included this year in this table.

Numbers and percentages are given for the base year 1981 and for 2001 and 2002. 
Table C.5 Equipment by place of origin: 2002

This table lists the total equipment purchases made by place of origin, which may differ from the vendor location. Both disbursements and number of purchase orders placed are given and include items purchased for training courses. The total amounts are therefore greater than the value shown under 'Equipment' in Table B.4. Disbursements may be made for equipment ordered in previous years; likewise there may be purchase orders placed for equipment for which payments will be made in future years. Direct costs are amounts for transportation, insurance, and other sundry items that were not attributed to places of origin, but are part of the equipment component. They are separate from miscellaneous costs, which are not reflected in this table. It should be noted that \$205 600 was spent on equipment for training courses in 2002.






