Statement of Financial Contributions to the Agency as at 17 September 2004

Note by the Director General

1. Statements of financial contributions to the Agency reflecting the situation as at the end of 2003 are contained in the Agency's Accounts for 2003¹. For the convenience of the General Conference, the contributions statements have been updated to reflect the situation as at 17 September 2004 and are reproduced in the annex as follows:

- Table 1A - Status of Regular Budget contributions for the year 2004;
- Table 1B - Status of contributions outstanding to prior years' Regular Budgets;
- Table 2 - Status of advances to the Working Capital Fund;
- Table 3 - Status of contributions to the Technical Cooperation Fund;
- Table 4 - Status of Assessed Programme Costs Payments.

2. Article XIX.A of the Statute reads as follows:

"A member of the Agency which is in arrears in the payment of its financial contributions to the Agency shall have no vote in the Agency if the amount of its arrears equals or exceeds the amount of the contributions due from it for the preceding two years. The General Conference may, nevertheless, permit such a member to vote if it is satisfied that the failure to pay is due to conditions beyond the control of the member."

3. For the information of the Conference, the following table indicates those Members to which Article XIX.A of the Statute applied on 17 September 2004. For each of these Members the table shows inter alia, the minimum amount payable in order to avoid the application of the above article.
