Introduction

The following pages contain financial and statistical data supplementing the Technical Cooperation Report for 2005. Again this year, the information is grouped under three headings as listed below, which allows the reader to make a comprehensive review of all information related to one subject. However, in a continuing effort to provide concise and transparent information, changes have been made in some of the tables from the presentation in 2003.

The countries are grouped by region in most of the tables. Annex 1 provides an alphabetical listing by region of all countries/territories that are mentioned in this report.

Unless otherwise specified, all amounts are expressed in United States dollars. As most figures are rounded to thousands of US dollars, the amounts in tables may not add up exactly to the totals shown due to rounding.

A. Resources and Contributions

The financial tables and graphs in this section show the resources received from various sources for technical cooperation activities.

B. Disbursement and Implementation Summaries

The financial tables and graphs in this section show actual disbursements (monetary outlays and in-kind support provided) and implementation against the adjusted programme for the year 2005 and, in some tables, for previous years as well.

C. Non-financial Indicators

The tables and graphs in this section provide figures on the actual physical outputs delivered through the technical cooperation programme, rather than the cost of the outputs. In some cases, figures on financial outputs are provided to complement that information.

The information contained in this Supplement is available in electronic format upon request. It is also available on GovAtom (restricted access). The Secretariat welcomes comments and suggestions for future improvements.

A. Resources and Contributions

Table A.1 Available resources: 1996–2005

This table shows resources by source of funding, based on the year in which the funds became available. The ‘other income’ of the Technical Cooperation Fund (TCF) includes national participation costs (NPCs) and assessed programme cost (APC) arrears received, interest income, and gains/losses on exchange. Other resources (extrabudgetary funds from Member States, organizations, United Nations Development Programme (UNDP), and in-kind) are shown separately.

Table A.2 Technical Cooperation Fund: 1996–2005

The ten-year development of the target for contributions to the TCF, the amounts pledged, and the payments against these pledges are shown. The payments as a percentage of the target gives the rate of attainment. In this table, contributions are shown not by the year in which they became available, but by the programme year for which they were pledged and paid. Therefore, new pledges or withdrawals against prior year targets, as well as payments, are recorded against that year, and the percentages for earlier years may change.

Table A.3 Member States’ contributions pledged and paid to the Technical Cooperation Fund: 2005

This table reports on pledges and payments to the 2005 TCF target, set at \$77 500 000. The table is sorted according to the percentage of the target pledged. Of the 139 Member States, 77 pledged their full target (or more), 15 made partial pledges, and 47 made no pledge in 2005.

Table A.4 Assessed programme costs and national participation costs

The table is divided into two parts. Part A reports on arrears of APCs as of 31 December 2005. Part B shows the amounts invoiced for 2005 under the new NPC mechanism, together with amounts that had been received as of 31 December 2005.

Table A.5 Status of extrabudgetary funds: 2005

This table shows the status of extrabudgetary funds from each donor. Included in this table under Part B are funds from countries for their own projects, designated ‘government cost-sharing’. A total of 58 countries and four organizations are represented. Also included is the Nuclear Security Fund. Amounts shown here refer only to funds made available to the Department of Technical Cooperation in accordance with Board directives to make use of the competencies of the Department in implementing the Nuclear Security Action Plan. The ‘Funds available 1 January 2005’ column of the table represents the total of the unliquidated obligations and the unobligated balance carried forward from the end of 2004.


Table A.6 In-kind support: 2005

In-kind amounts correspond to those reported in Table A.6.

AVAILABLE RESOURCES: 1996–2005





B. Disbursement and Implementation Summaries

Table B.1 Disbursement summary: 2005






Asia and the Pacific: \$17 125.1







Disbursements may be made for equipment ordered in previous years; likewise there may be purchase orders placed for equipment for which payments will be made in future years. Direct costs are amounts for transportation, insurance, and other sundry items that were not attributed to places of origin, but are part of the equipment component. They are separate from miscellaneous costs, which are not reflected in this table. It should be noted that \$47 800 was spent on equipment for training courses in 2005.


