Introduction

The following pages contain financial and statistical data that supplement the Technical Cooperation Report for 2007. Again this year, the information is grouped under three headings, which allow the reader to view comprehensively the data for each area of activity.

The countries are grouped by TC programme region in most of the tables. Annex 1 provides an alphabetical listing by region of all the countries/territories that are mentioned in this report.

Unless otherwise specified, all amounts are expressed in United States dollars. As most figures are rounded to thousands of US dollars, the amounts in tables may not add up exactly to the totals shown due to rounding.

A. Resources and Contributions

The financial tables and graphs in this section show the resources received from various sources for technical cooperation activities.

B. Disbursement and Implementation Summaries

The financial tables and graphs in this section show actual disbursements (monetary outlays and in-kind support provided) and implementation against the adjusted programme for the year 2007 and, in some tables, for previous years as well.

Montenegro declared independence from Serbia on 3 June 2006. After that date, the IAEA Membership of the former Serbia and Montenegro was continued by the Republic of Serbia. For its part, Montenegro became a Member of the IAEA on 30 October 2006. Amounts reported against "Serbia and Montenegro" in various tables in this section refer to disbursements for contracts entered into prior to 3 June 2006.

C. Non-financial Indicators

The tables and graphs in this section provide figures on the actual physical outputs delivered through the technical cooperation programme, rather than the cost of the outputs. In some cases, figures on financial outputs are provided to complement that information.

The information contained in this Supplement is available in electronic form upon request. It is also available on GovAtom (for registered users). The Secretariat welcomes comments and suggestions for future improvements.

A. Resources and Contributions

Table A.1 Available resources: 1998–2007

This table shows resources by source of funding, based on the year in which the funds became available. The ‘other income’ of the Technical Cooperation Fund (TCF) includes national participation costs (NPCs) and assessed programme cost (APC) arrears received, interest income, and gains/losses on exchange. Other resources (extrabudgetary funds from Member States, organizations, United Nations Development Programme (UNDP), and in-kind contributions) are shown separately.

Table A.2 Technical Cooperation Fund: 1998–2007

This table illustrates the ten year development of the target for contributions to the TCF, the amounts pledged and the payments against these pledges. The rate of attainment represents the percentage that is obtained by dividing the payments made to the TC Fund by the TCF target for a given year. In this table, contributions are shown not by the year in which they became available, but by the programme year for which they were pledged and paid. Therefore, new pledges or withdrawals against prior year targets, as well as payments, are recorded against that year, and the percentages for earlier years may change.

Table A.3 Member State contributions pledged and paid to the Technical Cooperation Fund: 2007

This table reports on pledges and payments to the 2007 TCF target, set at \$80 000 000. The table is sorted according to the percentage of the target pledged. Of the 144 Member States, 87 pledged their full target (or more), 14 made partial pledges, and 43 made no pledge in 2007.

Table A.4 Assessed programme costs and national participation costs

The table is divided into two parts. Part A reports on arrears of APCs as of 31 December 2007. Part B shows the amounts invoiced for 2007 under the new NPC mechanism, together with amounts that had been received as of 31 December 2007.

Table A.5 Status of extrabudgetary funds: 2007

This table shows the status of extrabudgetary funds from each donor. Included in this table under Part B are funds from countries for their own projects, designated ‘government cost-sharing’. Also included are funds provided to the IAEA through the Programme of Action for Cancer Therapy (PACT), the Nobel Peace Prize, and the Nuclear Security Fund. Amounts shown here refer only to funds made available to implement activities in the framework of the TC programme in order to meet the goals of the various individual funds. The ‘Funds available 1 January 2007’ column of the table represents the total of unliquidated obligations and the unobligated balance carried forward from the end of 2006.


Table A.6 In-kind support: 2007

In-kind amounts correspond to those reported in Table A.6.

AVAILABLE RESOURCES: 1998–2007











They are separate from miscellaneous costs, which are not reflected in this table. It should be noted that \$24 500 was spent on equipment for training courses in 2007.


