## **18. Strengthening the effectiveness and improving the efficiency of the safeguards system and application of the Model Additional Protocol** *(resumed)* (GC(55)/COM.5/L.6)

1. Mr BRADY (Ireland), speaking as chairman of the working group conducting negotiations on the draft safeguards resolution contained in document GC(55)/COM.5/L.6, said that a further round of negotiations had yielded some progress, reducing the number of paragraphs on which positions still differed. He intended to present a chairman's suggested text to the working group and, if agreement on it was reached, bring it to the Committee of the Whole at 3:00 p.m.
2. He commended the delegations that were taking part in the negotiations for their good humour and flexibility. He believed that all of them were determined to arrive at a text on which the Committee could agree.
3. The CHAIRPERSON took it that the Committee wished the working group to be given until 3:00 p.m. for further negotiations.
4. It was so agreed.

**The meeting was suspended at 1:00 p.m. and resumed at 1:10 p.m.**

## **15. Nuclear security, including measures to protect against nuclear and radiological terrorism** *(resumed)* (GC(55)/COM.5/L.11/Rev.2)

5. The CHAIRPERSON, in response to a request for clarification made by the representative of ALGERIA, confirmed that the document to be discussed under agenda item 15 was GC(55)/COM.5/L.11/Rev.2.

6. The CHAIRPERSON announced that the President of the General Conference had requested that the Committee of the Whole report to the Plenary at 3:30 p.m. She proposed that the Committee therefore meet at 2:00 p.m. — rather than 3:00 p.m. — in order to continue work on agenda items 15 and 18.
7. It was so agreed.

## **16. Strengthening of the Agency's technical cooperation activities**

*(resumed)*

8. The representative of PERU said that the text in document GC(55)/L.8/Rev.1 reflected the correction of minor typographical errors in document GC(55)/L.8 and the incorporation of an editorial amendment to paragraph 17, which now read “ ... and encourages all Member States receiving technical cooperation to sign an RSA Concerning the Provision of Technical Assistance by the IAEA”.

9. The CHAIRPERSON took it that the Committee wished to recommend to the General Conference that it adopt the draft resolution contained in document GC(55)/L.8/Rev.1.

10. It was so agreed.
